Financial Agreement

Full-Time and Part-Time Students

We understand that Coram Deo Classical Center makes financial decisions based upon its projected annual revenue. We agree that by registering our child(ren) in Coram Deo Classical Center, we are obligated to pay for a full year's tuition for each of our children enrolled in Coram Deo Classical Center. In the event that a student who is registered in Coram Deo Classical Center on a full-time or part-time basis wishes to withdraw from Coram Deo Classical Center between July 15 and September 1, the student's parents remain obligated to pay one-quarter of the full year's tuition. In the event that a student who is registered in Coram Deo Classical Center on a full-time or part-time basis wishes to withdraw from Coram Deo Classical Center after September 1, but before the completion of the first semester, the student's parents remain obligated to pay one-half of the full year's tuition. In the event that a student who is registered in Coram Deo Classical Center on a full-time or part-time basis wishes to withdraw from Coram Deo Classical Center after December 31, the student's parents remain obligated to pay one-half of the tuition remaining from the date of withdrawal to the end of the school year.

Methods of Payment

The first tuition payment is due July 1st. Families may choose to pay the remaining full year's tuition at once (due August 1), in two semester payments (due August 1 and January 1), or in 10 monthly payments on the first day of each month (August-May). Payment is made by standard method and must be cleared by the first of the month. Checks are to be made out to Coram Deo Classical Center.

A fee, set in accordance to any charges incurred by the bank, will be charged for all dishonored checks.

3. Submission to authority: Tutors are to be submitted to cheerfully, willingly, and expediently in all matters during instruction. Disrespectful or disruptive behavior, talking back, or willful disobedience will not be tolerated.
4. Language and conversation: Students are expected to speak in a manner that is respectful to peers, tutors, and administrators. Students should practice being slow to speak, quick to listen, and considerate of others. Speaking out of turn, coarse language or jesting, or side conversations during class are not permitted.
